Policy

The following policy sets out how CMLTM manages personal information collected through the web site.

What information is collected and why is such information collected?

CMLTM collects information required by current legislation and government agencies which may include: Personal, educational, certification and employment information. The type and amount of information collected may change based on the legal obligations outlined in the Act, Regulations, and By-laws.

How is the information used?

Information collected can be used in any of the following ways:

- To provide statistical reports to government agencies.

How does CMLTM protect the information collected?

The web site uses a SSL certificate with 256 bit encryption, so that any information passing from user to and from CMLTM is secure at all times.

Information is only retained for as long as it is required by legislation.

CMLTM does not currently use cookies.
