Guide for Canadian Educated Applicants Active: Practicing Registration

To work as a Medical Laboratory Technologist (MLT) in the province of Manitoba an individual is required to be registered with the College of Medical Laboratory Technologists of Manitoba (CMLTM).

The CMLTM was established in 2007 by the proclamation of The Medical Laboratory Technologists Act. MLTs must practice their profession in accordance with the CMLTM regulations, standards of practice, and meet the continuing competency program requirements. This protects the public's right to safe, effective, ethical service from Medical Laboratory Technologists.

Requirements for Active: Practicing Registration

- 1) Be a Canadian citizen, a permanent resident of Canada, or have an authorization to work under the Immigration and Refugee Protection Act (Canada).
- 2) Have a Canadian diploma/degree in Medical Laboratory Technology from a Accreditation Canada HSO-EQual accredited program.
- 3) Met the English Language Proficiency requirements as outlined in BOA-17 ([listed on the CMLTM website Policies page](#)).
- 4) Successful completion of the Canadian Society for Medical Laboratory Science (CSMLS) MLT examination or Canadian Alliance of Medical Laboratory Professional Regulators (CAMLPR) Field of Practice examination(s).
- 5) Have been actively engaged in the practice of Medical Laboratory Technology for 1,200 hours during the five (5) years immediately preceding the date of the application. Please refer to [BOA-06 Re-entry to Practice policy](#) if most recent MLT practice is outside the 5-year period.

Requirements for Inactive Certificate of Registration

- 1) Be a Canadian citizen, a permanent resident of Canada, or have an authorization under the Immigration and Refugee Protection Act (Canada).
- 2) Have a Canadian diploma/degree in Medical Laboratory Technology from a Accreditation Canada HSO-EQual accredited program.
- 3) Successful completion of the Canadian Society for Medical Laboratory Science (CSMLS) MLT examination or Canadian Alliance of Medical Laboratory Professional Regulators (CAMLPR) Field of Practice examination(s).
- 4) Been previously registered in the Active category.

Conditions for Inactive Certificate of Registration

- 1) May not practice Medical Laboratory Technology in the Province of Manitoba.
- 2) May not be referred to as a Medical Laboratory Technologist (MLT) or use the title in the province of Manitoba.
- 3) Must upgrade from Inactive to Active Certificate of Registration before beginning to practice Medical Laboratory Technology in Manitoba or begin to use the title Medical Laboratory Technologist (MLT).

Documents Required for Application to Active: Practicing Roster

- 1) Current CMLTM Application form completed (available in the [Resource Library](#)) and applicable annual fees.
- 2) Copy of the final transcript from the MLT program.
- 3) Evidence of English Language Proficiency as outlined in [BOA-17](#).
- 4) Copy of CSMLS or CAMLPR MLT certificate or exam results.
- 5) Copy of Canadian government issued photo identification (drivers license or passport).
- 6) If applicant is currently registered or has previously been registered (in the last 5 years) as an MLT in another regulated Province, a **Letter of Standing** from the regulatory body of that province must be provided
- 7) Criminal Record Check (with Vulnerable Sector Check)
- 8) Child Abuse Registry Check
- 9) Adult Abuse Registry Check
- 10) Proof of Professional Liability Insurance (PLI). For PLI options, please check out the [Liability Insurance Information Fact Sheet](#).
