### Guide for Applicants for Conditional Certificate of Registration

To work as a Medical Laboratory Technologist (MLT) in the province of Manitoba an individual is required to be registered with the College of Medical Laboratory Technologists of Manitoba (CMLTM).

The CMLTM was established in 2007 by the proclamation of The Medical Laboratory Technologists Act. MLTs must practice their profession in accordance with the CMLTM regulations, standards of practice, and meet the continuing competency program requirements. This protects the public's right to safe, effective, ethical service from Medical Laboratory Technologists.

#### Requirements for Conditional Certificate of Registration (Canadian Educated Applicants)

- 1) Be a Canadian citizen, a permanent resident of Canada, or have authorization to work under the Immigration and Refugee Protection Act (Canada).
- 2) Have a Canadian diploma/degree in Medical Laboratory Technology from a Accreditation Canada HSO-EQual accredited program.
- 3) Be eligible to write the Canadian Alliance of Medical Laboratory Professional Regulators (CAMLPR) MLT Field of Practice examination(s).

#### Requirements for Conditional Certificate of Registration (Internationally Educated Applicant)

- 1) Be a Canadian citizen, a permanent resident of Canada, or have authorization under the Immigration and Refugee Protection Act (Canada) to work in Canada
- 2) Have a Prior Learning Assessment (PLA) by CSMLS and completion of gap education identified. Information on the PLA process is available on the CSMLS website, [www.csmls.org](http://www.csmls.org), (click on the International Technologists tab), OR have a [PLA by CAMLPR](#) and completion of gap education identified.
- 3) Have met the English Language Proficiency requirements as outlined in BOA-17 ([listed on the CMLTM website Policies page](#))
- 4) Eligible to write the CSMLS MLT examination or CAMLPR Field of Practice examination(s)

### Conditions for Conditional Certificate of Registration

- 1) Must practice Medical Laboratory Technology under the direct-on-site supervision of a MLT holding a valid Active Certificate to Practice in the Province of Manitoba.
- 2) May be referred to as a Medical Laboratory Technologist and use the title MLT in the Province of Manitoba.
- 3) Must upgrade from Conditional to Active Certificate of Registration before beginning to practice Medical Laboratory Technology without direct-on-site supervision.
- 4) A Conditional Certificate of Registration is valid for 9 months or 3 attempts at the CAMLPR Field of Practice MLT examination(s).

### Documents Required for Application to Conditional Certificate to Practice (Canadian Educated Applicant)

- 1) Current CMLTM Application form completed (available in the [Resource Library](#)) and applicable annual fees.
- 2) Copy of the final transcript from the MLT program.
- 3) Copy of Canadian government issued photo identification (driver's license or passport).
- 4) Criminal Record Check (with Vulnerable Sector Check)
- 5) Child Abuse Registry Check
- 6) Adult Abuse Registry Check
- 7) Proof of Professional Liability Insurance (PLI). For PLI options, please check out the [Liability Insurance Information Fact Sheet](#).
- 8) Evidence of English Language Proficiency as outlined in [BOA-17](#).
